DESCRIPTION

Stretch cotton overalls blouse with functional inserts made of extra durable Tabiflex® material. The special cotton material Amalytton®, which is used for the production of the blouse, ensures increased strength and durability of cotton fabric while maintaining the comfort of elasticity and all the benefits of natural material such as breathability and pleasant wearing feeling. The blouse with stand-up collar has a slim anatomically shaped and functional cut SLIM FIT. Functional parts in the back area made of Tabiflex® extra flexible material contribute to even greater adjustment when moving. The blouse has a continuous zipper, is equipped with 1 zipper chest pocket, 1 zipper pocket on the left sleeve, 2 comfortable zipper side pockets, has an adjustable width of the sleeves and the bottom hem of the blouse with snap fasteners. The upper left part of the blouse is designed for placing the company logo in the form of printing and embroidery. The back of the blouse is equipped with functional ventilation. Increased visibility of the user is ensured by reflective strips located on the front and back and hi-vis accessories.
